2. Public Comment

No public comment.

3. Approval of February 4, 2025 minutes.

Kraig Boynton motioned to approve the minutes from the February 4, 2025 meeting. Greg Cassidy seconded the motion. Motion carried.

4. Presentation by Lindsey Kerr from LifeLine Pilots

Lindsey gave a presentation on this not-for-profit agency that matches volunteer pilots with patients needing to travel out of the immediate area for non-emergency medical care. They can also transport loved ones to patients out of the immediate area.

There is no cost for their services. LifeLine Pilots is not funded by government funds, but by non-governmental grants, fundraising, and donations. Lindsey said that 3.6 million patients do not receive medical care due to transportation barriers. Aviation can be a great solution, as they can fly into smaller airports and can go up to 1,000 miles throughout the Midwest and beyond because there are sister organizations around the country to partner with for longer flights. LifeLine Pilots gave over \$2 million in free flights last year.

The agency requires 4-5 days' notice and a physician's release. The patient needs to find their own accommodations and ground transportation, needs to be able to sit upright, be ambulatory, and demonstrate a financial or compelling need.

The pilots are all volunteers with their own planes, at least 21 years old, 250 hours of flying/instruction, in good standing with the FAA, love to fly and help others. The agency has a 100% safety record, and they have been in business since 1981. Besides transporting passengers, they also

deliver supplies to devastated areas where the large airports have closed, but they are still able to land at smaller airports.

5. Approval of HSTP Region 5 Update Document:

Kylie Rathmann motioned to approve the HSTP Region 5 Update Document, and Jodi Scott seconded the motion. Reema stated this document is updated about every five years per IDOT. She shared a presentation of the final updates of the document, and pointed out the following changes:

- a. She fixed some spacing and formatting issues
- b. A new photo was added to the front middle bottom
 - i. The taxi company that operated the Washington Senior Taxi service has changed, so the photo was changed to show a TDK Event Services van with a rider.
- c. She updated the list of “other transportation options” in Appendix B (p. 103)
 - i. Added Reliable Cab Havana and Transcare Plus
 - ii. She deleted PPAW Transportation, Midstate Limo, and Peoria Limousine because their websites were no longer functional.
 - iii. One cab company and two shuttle bus services that are closed or nonexistent were removed (one as of March 2025!).
 - iv. She included only companies with what looks like an updated website; and added some because she had seen them shuttling through the area.
- d. Updated the bylaws in Appendix C from the February meeting.

Reema will take this to Tri-County’s Technical Committee, and if all goes well, they will recommend it to the Full Commission. At the end of this time, this plan should be fully approved.

6. Provider and Agency Updates

Tri-County Regional Planning Commission

Adam Crutcher reported that he is working on the City of Peoria Bike Plan, and the Bartonville Active Transportation Plan, which includes transportation options like walking and biking.

City of Galesburg

Kraig Boynton reported that they found out today they will receive seven

paratransit buses on Friday. They need to order the fixtures for the heavy-duty buses they will be getting. They completed the study for the county-wide transportation and are working with the county to secure the funding so they can get the local match.

Pekin Park District

Alisha Dault had nothing to report.

Advocates for Access

Jodi Scott had nothing to report.

Paratransit user

Chris Mitchell reported that she had a great driver today, but she is sometimes treated unfairly. Riders' self-judgement is often questioned. For example, which door to get dropped off at, or how to get on a vehicle, and they risk being denied service if the driver does not agree with what they know their capabilities are.

WeCare

Darren Howlett had nothing to report.

Washington Township

Jim Bremner reported that more transit van riders are asking to go to Peoria for medical care, more are ambulatory challenged, so they are dropping the age of service to 62 to accommodate more riders.

Greater Peoria Mass Transit District (GPMTD)

Dr. ShamRA Robinson reported that on March 19, GPMTD started Travel Training for students and teachers at Dunlap High School with 10 students with disability challenges. They were shown how to get in and out of the bus, how to pay, and how much to pay. Dr. Robinson said that they want to make sure the students understand how to travel safely.

Angel Marinich reported that their driver numbers are increasing, and their on-time performance is increasing.

Cast Technologies

Kylie Rathmann reported that she is still having issues with employees having trouble getting to work at 5:00 a.m. They have to be at their station and ready to work by 5:30. Some cannot make it, and it holds up production.

Central Illinois Agency on Aging (CIAOA)

Shannon Peterson reported they are hiring some new employees to help with the transportation program to better assist their clients, and they are constantly brainstorming ways to improve the program.

Tazewell PCOM

Dawn Cook reported they are getting ready to take their application for 5311 and DOAP (Downstate Operating Assistance Program) to the board.

Center for Sight and Hearing

Monica Vandeven reported they have a support group every month for blindness and low vision at Advocates for Access in Peoria Heights.

IDOT

Melissa Ohrwall reports they will have the next CVP (Consolidated Vehicle Procurement) application this summer

MSW Projects

Traci Dowell reported that they have completed the 5311 and DOAP grants. They are down to one van with a lift, and it is finicky.

Central Illinois Agency on Aging (Galesburg)

Katy Deadmond reported that Galesburg is working on becoming a dementia-friendly community, and they are hosting a kick-off event on May 2 from 5:00 – 8:00 p.m. at the Kensington Ballroom in Galesburg. It is open to the public.

Thrive Community Services
