The Mayor Zimmer asked for public comments on any action to be taken on Agenda items. There were none.

Parking that is visible from the street along the business must be paved. Parking that is not visible from the street does not have to be paved. Discussion was held concerning the difference between the gravel and hard surface. Passed on roll call vote with Getz, Peterson, Prather, Germann, Chambliss, Hinnen, Teegarden, and L. Klaus all voting Aye.

Moved by Teegarden, second by Prather, to authorize Mayor Zimmer to sign a Release of Mortgage for pay off of the CDAP loan taken by SoBrite. Passed on roll call vote with Teegarden, Prather, Germann, Peterson, Chambliss, Hinnen, Laurie Klaus, and Getz all voting Aye.

Committee Reports:

Chairman Prather of the Budget Committee: Two items are still needed for the tax levy.

Chairman Getz of the <u>Administration and Personnel Committee</u>: Melissa reported that we don't have an insurance bid yet. The broker says the renewal rate will not be available until November 1.

Chairman Hinnen of the Enterprise Committee: Storm sewer at end of Tower is completed and came in under budget. Sewer line begins Wednesday.

Chairman Hinnen of the <u>Maintenance Committee</u>: One round for leave collection has been made. Not many leaves last week, but with wind today there will be plenty of leaves this week. The last collection is before Thanksgiving.

Chairman L. Klaus of the <u>Public Safety Committee</u>: Middle School students washed the squad cars as part of their service project day.

Chairman Germann of the Park and Recreation Committee: No report

Chairman Teegarden of the Economic Development Committee: No report

Chairman Mayor Zimmer of the Liquor Committee: No report

New Business: The Mayor noted that Rusty has been working on ADA parking and areas to the new City Building. There will be stairs on the front and a ramp on the side of the building.

Recycling is being researched as to rates. This report will be coming soon.

Questions were asked about the spray patching on Rt. 117. Rusty asked the State if we could do this since the State patching does not last as long as what our employees do. We will not be reimbursed for this. Rusty noted that we stayed within the budget

Public Comments: Kent McCanless reported that a FEMA grant covered the cost of \$50,000 for the Tri-County multi-jurisdictional natural hazard mitigation plan.

There being no further business to come before the Council the meeting adjourned at 8:25 p.m.
